**Sumy National Agrarian University**, hereinafter "University", represented by the rector of Ladyka Volodymyr Ivanovich, acting on the basis of the Statute, on the one hand and Agroinvest LLC, hereinafter "Enterprise", in person director Petrov Serhiy Mykolayovych, which (which) acts on the basis of statute (order, mandate), on the other hand (when the parties are collectively referred to as the "Parties"), concluded this agreement on the following

**I. SUBJECT OF THE CONTRACT**

1.1. Organization of internships for students of higher education at the first (bachelor's)/second (master's) level E&M of the SNAU Faculty on the Practice Base Agroinvest LLC in accordance with the terms of this Agreement.

**II. OBLIGATIONS OF THE PARTIES**

**2.1. The practice base undertakes:**

2.1.1. To accept higher education applicants for practice in accordance with the curriculum the second (master's degree) level

2.1.2. Notify SNAU about the arrival of the applicant(s) for practice.

2.1.3. Appoint by order, from among the highly qualified specialists of the enterprise, the head of the practice.

2.1.4. Organize internships for SNAU graduates.

2.1.5. Create appropriate conditions for applicants to complete the practice program, prevent their useapplicants' work for purposes not provided for by the educational and professional program.

2.1.6. Create safe working conditions for applicants at each workplace, as well as appropriate conditions for practice at the production/workplace, compliance with the rules and norms of labor protection, life safety and industrial sanitation in accordance with the legislation.

2.1.7. Provide applicants with safe working conditions at a specific workplace. Conduct mandatory training on labor protection. Train apprentices in safe work practices as needed. Provide special clothing, protective equipment, medical and preventive care according to the standards established for full-time employees.

2.1.8. Provide interns and practice managers from the institution of higher education with the opportunity to use laboratories, offices, workshops, libraries, online resources, technical and other documentation necessary for the implementation of the practice program.

2.1.9. Provide accounting of interns' departures to work. All violations of labor discipline, internal regulations and other violations that occurred during the internship should be reported to SNAU.

2.1.10. At the end of the internship period, give a written description of each intern, as well as assist in the preparation of the internship report and the preparation of all necessary documents.

2.1.11. To provide applicants with the opportunity to collect information for course/diploma works based on the results of the company's activities, which is not a commercial secret, based on the referrals of cyclic commissions.

2.1.12. Additional conditions \_\_\_\_\_

2.2. SNAU undertakes:

2.2.1. To properly fulfill the terms of this Agreement.

2.2.2. Before the start of the internship, submit the internship program to the internship base for approval, and no later than a week later - the list of applicants who are sent to internship

2.2.3. Appoint qualified teachers as practice leaders and carry out educational and methodical guidance in accordance with the Regulation on the practice of students of higher education of the Sumy National Agrarian University.

2.2.4. To ensure that all organizational measures are carried out before the interns' departure: briefing on the practice and safety techniques, provision of relevant documents required for the practice (direction, program, diary, individual task, etc.).

2.2.5. To ensure compliance by applicants with labor discipline and the rules of the internal labor regulations of the practice base. To participate in the investigation by the commission of the practice base of accidents, if they happened to the applicants during the practice.

### **III. RESPONSIBILITY OF THE PARTIES**

3.1. The parties are responsible for non-fulfillment of their obligations regarding the organization and conduct of practice in accordance with the current legislation of Ukraine.

3.2. All disputes arising between the parties under the Agreement shall be resolved in accordance with the current legislation of Ukraine, including, but not limited to, the labor legislation of Ukraine.

### **IV. TERM AND OTHER TERMS**

4.1. This Agreement enters into force from the date of its signing by the parties and is valid until " \_\_\_\_\_ " year.

4.2. The Agreement is terminated:

4.2.1. by mutual consent of the parties;

4.2.2. prematurely at the initiative of one of the parties in case of violation by the other of the terms of this Agreement;

4.2.3. in other cases provided for by the current legislation of Ukraine.

4.3. Amendments and additions to the Agreement are made by mutual consent of the parties through renegotiation or conclusion of additional agreements to it.

4.4. For the implementation of individual provisions of this Agreement, the parties may enter into additional agreements, which after their signing become an integral part of this Agreement.

4.5. The parties undertake to observe confidentiality and prescriptions of the current legislation of Ukraine regarding information, documentation, knowledge, experience that became known during the practice.

4.6. Practice during martial law in Ukraine and quarantine, established in accordance with the current legislation of Ukraine, can be partially conducted online.

4.7. The contract is concluded in the Ukrainian language in two authentic copies having the same legal force, one for each party.
