REQUIREMENTS FOR COMPLETING ABSTRACTS

1. *The volume of the paper:* up to 3 full pages, including figures, tables, references. The design of the text part, figures and tables must meet the generally accepted requirements for the design of scientific publications.

2. *Technical parameters:* text editor MS Word; font – Times New Roman; pin size - 14; line spacing – 1 cm; paragraph - 1.25 cm; top and bottom margins are 2.5 cm, inside and outside margins are 2.0 cm.

3. *Layout of figures and tables:* must be submitted in the paper directly after the text, where they are mentioned for the first time, or on the next page. Figures must be a single graphic object (scanned objects are prohibited). Design of figures and tables should be black and white, using Times New Roman font; pin size - 12; line spacing is 1.0. The source should be indicated under the tables and figures. Layout of tables in landscape format is not allowed.

4. *Formulas:* execute in the Microsoft Equation formula editor.

5. *References:* is drawn up taking into account the developed National Standard of Ukraine DSTU 8302:2015 "Information and documentation. Bibliographic reference. General provisions and rules of drafting" (<http://surl.li/dlknf>). The list of references should not exceed 5 items. In the text, references are indicated by square brackets indicating the serial number of the source in the list and the page (page) numbers after a comma, for example: [1, p. 25].

The files should be named according to the thematic direction of the conference and the author's last name, for example: 3_ Hordiyenko_tezi.

Post-graduate students and students of higher education indicate information about the scientific advisor.

THE AUTHORS AND SCIENTIFIC ADVISORS ARE RESPONSIBLE FOR THE CONTENT OF THE MATERIALS.

Reports that do not meet the specified requirements will not be considered. The materials received from the conference participants are published in the author's editorial original.

The number of co-authors should not exceed three people. Materials that have not been published before are accepted for the conference.
